ORDER

Para 13.4 of the Revised Instructions on Ombudsman, read as 1st paper above, states that the State Government shall set up a three-member Appellate Authority, consisting of an academician, a retired civil servant and a civil society representative, to consider representation by any party aggrieved by the awards of the MGNREGA Ombudsman. As Ombudspersons had been appointed as per the Government orders read as 2nd & 4th papers above, it is imperative now that the Appellate Authority shall be constituted.

2. As per the Government order read as 3rd paper above, a Search Committee had been constituted to identify and recommend to Government the suitable persons to be appointed as members of the Appellate Authority (Ombudsperson) under MGNREGA, as per the aforesaid instructions and the Committee submitted their recommendations.

3. Government have examined the recommendations of the Search Committee and are pleased to constitute an Appellate Authority (Ombudsperson) under MGNREGA by including the following
